### 1. Qualification of Applicants

1.1. Applicants must hold a bachelor's degree in any field from an accredited academic institution. All applicants must have a cumulative GPA not less than 2.75.

1.2. Applicants, currently employed, must obtain written approval from their employer to pursue full time study at NIDA.

No refunds will be issued. If an applicant has already been accepted but is subsequently determined to be unqualified, scholarship awards will be canceled.

## 5. Selection Procedures

The program committee will decide which applicants are to be interviewed by the faculty members of the Graduate School of Public Administration. The committee will evaluate applicants based in credentials, education, and experience.

## **6. Terms and Conditions for Scholarship Recipients**

### **6.1 Eligibility for Scholarship**

#### **6.1.1 Good Learning Scholarship**

**1) Recipients of the Scholarship Type 2 must have:**

- A minimum cumulative GPA of 2.75 for the Bachelor's Degree

**2) Recipients of the Scholarship Type 3 must have:**

- A minimum cumulative GPA of 2.50 for the Bachelor's Degree

#### **6.1.2 International Relations Scholarship**

The recipient of the International Relations Scholarship must be a foreign student whose university has a relationship or is under the MOU with the latitude. In this regard, the Scholarship approved is left to the discretion of the Dean/Director Meeting for Education.

### **6.2 Amount of Good Learning Scholarship and International Relations Scholarship**

**6.2.1** Recipients of the Scholarship Type 2 shall be completely exempt from the entire tuition fee throughout the program

**6.2.2** Recipients of the Scholarship Type 3 shall be completely exempt from a half tuition fee throughout the program

### **6.3 Scholarship Requirements**

#### **6.3.1 Good Learning Scholarship**

Recipients of the Scholarship Type 2 and 3 shall maintain a minimum GPA of 3.30 in each semester. If the GPA fails to meet the criterion for any semester, the scholarship shall be immediately discontinued.

#### **6.3.2 International Relations Scholarship**

Recipients of the Scholarship Type 2 and 3 shall maintain a minimum GPA of 3.30 in each semester;

6.3.3 The recipient's leave of absence for any semester shall result in immediate cancellation of the scholarship. If resigning from the Institute or cancelling the scholarship, the recipient shall reimburse the award scholarship in full to the Institute, unless the Committee considers otherwise;

6.3.4 In the event that scholarship recipients have to repeat any course, they shall not be exempt from the tuition fee for such re-enrolled class;

6.3.5 In the event that scholarship recipients wish to enroll in any course beyond their study plan, they shall be exempt from the tuition fee of such class upon recommendations in respect of the advisor only;

6.3.6 Scholarship recipients shall be exempt from the fee for the first-time comprehensive examination only, Consecutive comprehensive examinations shall not be exempt;

6.3.7 When the scholarship period ends, the student status retention fee shall be paid by scholarship recipients themselves;

6.3.8 Scholarship recipients shall work for the graduate school or the Institute at least 6 hours a week;

6.3.9 The recipient has no rights to apply for any other scholarships of the Institute, except for the financial aids for research conduct and publication allocated from the state budget.

**6.4 Scholarship recipients who are International students shall abide by the health Insurance policy stipulated by the Institute. If not, they forfeit their scholarship.**

**6.5 Standard Duration of Scholarship** (Counting from the first day when the scholarship recipient is registered as a student)

The award period shall be 2 years.
